1. The candidates, whose registration numbers, are provided here below are requested to log into their portal and verify the accuracy of the following particulars before they are published in the Kenya Gazette:

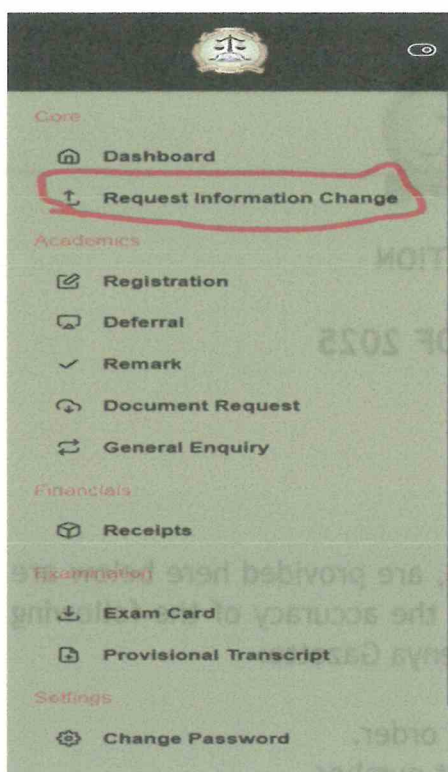
- a) Full name, including spelling and order.
